**Note:** Rank in the Merit List of those Candidate having same Marks in HPNLET-2018 will be decided on the basis of following rules:

1. Candidate having higher marks (aggregate) in 10+2 Examination shall be given higher rank.
2. If marks in 10+2 Examination is same, then candidate having higher marks in his/her 10<sup>th</sup> Examination (aggregate) shall be given higher rank.
3. If marks obtained in 10+2 and 10<sup>th</sup> Examination, both are same then then the candidate higher in age shall get preference.

## FEES STRUCTURE

The fees structure of the Himachal Pradesh National Law University is enclosed herewith. On the date of admission, candidates are required to deposit Rs. 2,20,500 (Two Lac Twenty thousand and five hundred) either by NEFT/RTGS [Bank: UCO Bank, Account No: 14100110046586, IFSC Code: UCBA0001410, Branch: Halog, Dhami, District Shimla, Himachal Pradesh], or **Cash** or through **Bank Draft** in favour of "**Registrar HPNLU**, payable at Shimla".

The candidates failing to deposit the requisite Fee and necessary documents on the admission date, will lose their right to be considered for admission under HPNLET-2018 and their names will be dropped from the HPNLET admission process. For fee details, and related Refund Rule, please see the Annexure enclosed herewith.

## COURSE OPTIONS

Each course i.e. B.A. LLB and B.B.A. L.L.B has 60 seats including reserved seats. Candidates may opt either B.A.LLB or B.B.A.L.L.B depending on their **Inter SE** merit on the date of admission.

3. HPNLET-2018 Admit Card
4. Four copies of latest Passport size photographs
5. ADHAR Card/Universal Identification Number (UID)

#### **REFUND RULE**

As per Himachal Pradesh National Law University, Shimla Courses of Study, Admission, Curriculum and Examination Regulation, 2016, any candidate who withdraw his/her admission, the fee deposited by him/her shall be governed by following rule:

*“A candidate cannot claim refund of any amount which he/she has deposited at the time of his/her admission to any course.*

*However, in case, last date of admission is not over, or the classes have not commenced whichever is earlier, the Registrar in consultation with the Vice-Chancellor may decide as to the amount which may be refunded. But, in no case the amount should exceed one-fourth of the total fee paid.”*
